“Any dispute arising in connection with the present contract shall be settled under the Mediation Rules of the Arbitration and Mediation Center of the Mauritius Chamber of Commerce and Industry (MARC). In the event that no settlement is thereby reached within [...] days of the commencement of the mediation, or such further period as the parties shall agree in writing, the dispute shall be finally settled under the Arbitration Rules of the Arbitration and Mediation Center of the Mauritius Chamber of Commerce and Industry (MARC), by [either one or three] arbitrator(s) appointed in accordance with the said rules.”

Arbitration and Mediation are alternative dispute resolution methods which, when used within the right parameters such as those given by an ADR institution, are excellent alternatives to long, relationship wounding and costly state court proceedings.
